INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

The COGCC Orphan Well Program plugged the Bert Eaton (OWP) #1 well and decommissioned the well site in January 2023. Soil samples were collected in accordance with the Initial Form 27 for the project and COGCC Rule 915.e(2)B. No production equipment and/or flowlines were present on the well site at the time of plugging and site decommissioning. Initial assessment and sampling occurred on January 26, 2023, and did not indicate soil impacts above COGCC standards as described in the Site Investigation Report section below.

Proposed Soil Sampling

All areas suspected of having potential impacts, including the wellhead, were visually inspected and field screened with a PID. Using these observations and field screening results, soil samples were collected from areas most likely to be impacted.

One discrete soil sample was collected from the wellhead excavation. No production equipment and/or flowlines were present on the well site at the time of plugging and site decommissioning. Soil samples were submitted for laboratory analysis of Table 915-1 constituents. The attached project map provides the location of all samples.

No groundwater was encountered during the initial assessment and sampling conducted on January 26, 2023.
