Comment:

	<p>This location does not comply with Rule 1004. Previous inspections (Doc #682503663 and #668702394) documented that the cut bank on the southwestern portion of the location were exposed/bare soil with little vegetation establishment. It was observed during this inspection that the cut banks remain exposed/bare and have little desirable plant species evident. Additionally, two track access road remains that will require additional reclamation activities before the location meets final reclamation standards. Refer to attached inspection photos for documentation.</p>	
Corrective Action:	<p>Comply with Rule 1004. Reclaim access/lease roads and reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management. CA date is being back-dated to when final reclamation activities should have been completed, 11/15/2018 (Doc #682503663).</p>	Date 11/15/2018
