This location is within or in close proximity to a Parks & Wildlife (CPW) District with Black Bear/High Priority/NSO/Density Habitat regulations.

While there during normal production operations the following compliance issue was observed:

1. Stormwater BMPs need implementation and maintenance.
2. Gas meter calibraton card not visibly displayed.
