On April 27, 2023, COGCC staff Chris Binschus, had a discussion with the surface owner regarding the previous corrective action to perform additional reclamation. The surface owner stated there was never any correspondence with PDC regarding the previous corrective action. The surface owner has since reseeded that entire corner portion, including the well location, with a no-till drill and seeded a mixed introduced/native grass mix.

Staff did document that the entire corner portion has been reseeded by the surface owner. Refer to the attached inspection photos.
