Tank battery- The previous inspection was conducted four year prior and perennial vegetation has failed to establish. The majority of the location is annual tumbleweeds. The adjacent reference area has the establishment of perennial grasses with annual tumbleweeds. Refer to the attached inspection photos.  CA: Comply with Rule 1004. Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.			

Summary  
 On March 30, 2023, H2 mobilized to location. The site was deep ripped to a depth of 18-inches, vibrashanked and disced to prep seedbed, then drilled in Dryland Grass seed mix with QuickGuard, one bale of certified weed free straw was blown across site and crimped into dirt. The site measured 0.5 acres.
