Operator Comment: As discussed with John Heil with the COGCC, on April 25th at 1:06 PM, this is an on going reclamation site, we had to stop shredding soil last fall due to snow and weather. We need to sample the site and run analytical results to see if the soil is under the Table 915-1 requirement. We are planning to do this when we have other areas to sample, if it is under the requirements, we will submit the appropriate Form 27S, if the soil analytical is not below the requirements, we will continue shredding the soil.

COGCC Representative: This is a partial denial of the resolution: CAs regarding fencing and EPS contact requirements appear to have been addressed.

Based on the photo provided, erosion log placed at the base of the soil stockpile has not been installed in accordance with good engineering practices (trenched/backfilled); gaps beneath the erosion logs and soil surface are apparent.
