I hope you had a great weekend. As follow up to your email below, attached are corrected spreadsheets for the Wells and Facilities Lists.

Related to Issue #2, a few notes on the NOAVs:

- NOAV #403197216 – Production Reporting
  - I believe this matter is currently in the settlement phase between D90 and COGCC per communications between D90 and the COGCC via D90's counsel Davis Graham & Stubbs.
  - As such, I believe this NOAV should stay with D90 since it is close to being resolved.
- NOAV #403258393 – Missing 2021 Bradenhead Tests
  - Formal response to this NOAV was filed in February 2023 via D90's counsel Davis Graham & Stubbs, but I do not currently know the status of COGCC's response
  - Because the response was filed under D90 as the operator, is it better to keep it under D90?
  - Lastly, FEO also received what appeared to be a duplicate NOAV for the missing 2021 Bradenhead Tests. FEO submitted a response to the NOAV separate from D90.

If D90 were to retain these two NOAVs for the aforementioned reasons, would that create an issue with paperwork that has already been filed?

Good afternoon Daniel and Ryan,

I have reviewed the above captioned Form 9 transfer and have noted the following issues.

**Issue 1:** Both the Wells and Facilities Transferred and Incidents Transferred Lists indicate that the current operator is Fulcrum Energy Operating. Since these items have not transferred in our database, the current operator should be listed as D90 Energy LLC or the current operator in the database should it be a legacy operator.

**Solution 1:** Please correct both spreadsheets and resubmit by emailing the revised spreadsheets to me.

**Issue 2:** There are two Unaccounted for Related Incidents that will need to be accounted for before the transfer can proceed.

NOAV #403197216

NOAV #403258393

**Solution 2:** Both the Intent and Subsequent attestations indicate that D90 Energy LLC is not retaining the responsibility for any incidents. As a result, both NOAVs will need to be added to the Incidents Transferred list.

Assuming the other Form 9 requirements are met, all Form 9s shall now be passed with the following two COAs:

The Buying Operator must file a *Form 3, Financial Assurance Plan*, within 10 business days of Form 9 approval. Per Rule 702, Buyer will then provide any required additional financial assurance as soon as practicable but no later than 90 days from the Commission's approval of the *Form 3, Financial Assurance Plan*.

The Selling Operator must file a *Form 3, Financial Assurance Plan* within 10 business days of Form 9 approval. Per Rule 702, Seller will then provide any required additional financial assurance as soon as practicable but no later than 90 days from the Commission's approval of the *Form 3, Financial Assurance Plan*.

I have received acceptance of the COAs from Ryan Sullivan of Fulcrum Energy Operating. I will just need the emailed acceptance from D90 Energy LLC.

When resubmitting the Form 3, please use the following comment.

This Form 3 Document #\_\_\_\_ is submitted as a result of an approved Form 9 Transfer of Operatorship and it replaces Form 3 document # \_\_\_\_.
