Comment:

The crop has not re-established at the location. There is an area approximately 250ft x 100ft with no crop stubble. It appears there could be a historic impact to soils from the abandoned wellsite. Operator will need to submit a form 27 to investigate and sample soils per Rule 913. The soils will need to be evaluated to determine the soil issues preventing crop establishment. Currently the field is fallow and has not been planted. Prepare the location before the next planting season per landowner ag activity.
