COGCC Inspection Report Summary

On Tuesday 5/9/2023 at approximately 09:20, I, Inspector Tom Peterson, conducted an on-site follow inspection at the KPK Koester Pad 18-33 Location #332775 in Weld County, Colorado.

While there, I observed that the DCP gas sales meter station #237082 appeared to have current product sold. The following possible compliance issues were observed: Immediately cease all gas sales pursuant to Order 1V-863 with a corrective action date of 2/22/2023.

Further gas sales from this battery is a violation of Rule 219 and Order 1V-863.

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
