<p>COGCC Inspection Report Summary On Tuesday 5/9/2023 at approximately 10:00 hours, I, Inspector Tom Peterson, conducted an on-site follow up inspection at the KPK Sunmarke Tank Battery location #442153 in Weld County, Colorado. While there, I observed that the DCP gas sales meter station #235878 appeared to have current product sold. The following possible compliance issues were observed: Immediately cease all gas sales pursuant to Order 1V-863 with a corrective action date of 2/22/2023. Further gas sales from this battery is a violation of Rule 219 and Order 1V-863. Wells associated with this battery are: Sunmarke 15-28 API #123-24646, Sunmarke 19-28-12 API #123-35079, Sunmarke 19-28-11 API #123-35080, Sunmarke 19-28-14 API #123-35081, and the Sunmarke 19-28-14 API #123-35082. A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
