Identified rill erosion has been repaired and dressed up, and sediment basin has been seeded and hydro-mulched to provide stabilization. The culvert at the entrance has been removed and replaced (this has also been identified in the Corrective Action regarding the removal of debris and trash). The actions completed to comply with Rule 1002.f. and work towards improving and maintaining the location.
