	Operator shall perform final reclamation activities in accordance with Rule 1004 standards. (Reclamation Specialist #143)
	Reclamation Specialist agrees with Environmental Staff determination that elevated pH sample from the wellhead may not be associated with E&P activities. The exceedance in pH is likely due to the well bore sample taken at the cementing area between and around the surface casing and the production casing. The concerned area is very narrow/localized (approximately 6' bgs), and is below the likely root depth; it will likely not influence the plant community to any significant degree. Therefore, Reclamation Staff has not conducted a technical review of the Operator provided Reclamation Plan at this time. (Reclamation Specialist #143)
	Form 27 "Remediation Completion Summary": Operator's Answer to "Do all soils meet Table 915.1 standards" is "Yes". Operator is submitting a Rule 915.b Request to leave inorganic exceedances in situ, therefore soils do not meet Table 915-1 Standards. COGCC Reclamation Specialist changed answer from "Yes", to "No". (Reclamation Specialist #143)
	Based on the information presented, the elevated pH sample from the wellhead may not be associated with E&P activities. It appears that no further remedial action is necessary at this time and the COGCC approves the closure request. However, should future conditions at the site indicate contaminant concentrations in soils exceeding COGCC standards or background levels or if groundwater is found to be impacted, then further investigation and/or remediation activities may be required. NOTE: This no further action determination is contingent on implementation of the approved reclamation plan.
	COGCC acknowledges the following statement: "The 5300' of flowline is a shared flowline with the LILLI UNIT 08-01 and will be abandoned when the other wells on the line are cut/capped". However, Operator shall submit a separate Form 27 Initial for abandonment of the associated flowline for approval.
