

PLUGGING RECORD

INSTRUCTIONS

Within thirty (30) days after the plugging of any well, the owner or operator thereof shall file this form in duplicate for wells on Patented or Federal lands, and in triplicate for wells on State lands, give a detailed account of the manner in which the abandonment or plugging work was carried out, including the nature and quantities of materials used in plugging and the location and extent (by depths) of the plugs of different materials; records of the amount, size and location (by depths) of casings and junk left in the well; and a detailed statement of the volume and weight of mud fluid used.

DETAILS OF WORK

SURFACE CASING: 8-5/8" OD 19.64# casing, set at 293'. Cemented with 210 sacks cement, 4% gel and 2% CC.

PRODUCTION CASING: 4-1/2" OD 11.60# J-55 casing set at 4518'. Cemented with 100 sacks cement, 2% gel.

PLUGGED BACK TOTAL DEPTH Baker Model "N" Cast Iron Bridge Plug at 4450'.

TOP OF CEMENT: 3645'.

TOP OF PERFORATIONS: 4380'.

PLUGGING PROCEDURE: Filled hole from 4447' with 100 gallons sand and three sacks cement, filling hole to 4296'. Shot pipe off at 3515' and pulled 4-1/2" OD 11.60# J-55 casing, leaving approximately 1003' of casing in hole. Filled hole with heavy mud from 4296' to 296'. Pumped 25 sacks cement by Halliburton from 296' to 224'. Cut 8-5/8" surface casing off 5' below top of ground and filled hole with heavy mud to 25'. Dumped 10 sacks cement to top of surface casing and wilded cap on surface casing.
