General Comment:**COGCC Inspection Report Summary**

On Wednesday 5/10/2023, I, Inspector Scott Ramsey, conducted a routine inspection at Gils hot oil service State 3-X, at Location # 324702 in Jackson county Colorado.

Any Corrective Actions from previous Inspections that have not been addressed are still applicable.

While there, I observed well pump jack not operating at time of inspection. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management Area.

Previous Inspector has C/A's for stored equipment, lack of Braden head and stained soil from inspection # 689806733.

During this inspection the following compliance issues were observed:

1. No BMP's installed to prevent sediment migration from occurring on location.
2. Location and access is covered with vegetation.
3. Lease road shows signs of lack of stabilization/compaction.
4. Access road to well is not marked or maintained
5. No API posted on well head and partial emergency contact
6. Battery signage is lacking information
7. Secondary containment is insufficient.
8. No evidence of Braden Head access.
9. Valves on tanks missing cap/plug
10. Tank is open to atmosphere through hole on side of tank with hose pushed into. Strong hydrocarbon odor.
11. Stored equipment on location
12. Random debris
13. Staining at well head
