

Note- there was no perimeter BMP at the base of the fill slope.



**Photo 7.** Photo taken from western fill slope, facing South. Photo illustrates the point of sediment laden stormwater discharging off location without a perimeter BMP (red arrows indicating no perimeter BMP).

Note- there was a ditch BMP installed during the initial construction; however, the ditch no longer exists to direct stormwater into the sediment trap and recent disturbances near the red arrows failed to re-install the ditch BMP.
