On Friday, April 28th, one day after the inspection report was received by Denova Sequestration, LLC (Denova), Ricardo Mendez, Senior Drilling Engineer for Denova, conducted an onsite to verify that all trash was disposed of and to survey for any other issues related to proper maintenance of the site. Mr. Mendez confirmed that all trash has been removed from the site. To ensure that Rule 606 is properly followed, Denova and IPT Well Solutions have assigned personnel to tour the site every few hours to ensure good housekeeping is maintained at the location throughout drilling operations.

Consistent with the approved Stormwater Management Plan, Denova installed a combination of temporary and permanent stormwater controls at the location, including drainage ditches around the perimeter of the well pad location consistent with the Roadside Ditch Section detail provided on page 3671-C-7000 of the approved Construction Layout drawings, sediment basins, topsoil segregation, seeding, and mulching. Since constructing the location, Denova has experienced a series of stormwater events and observed that all stormwater controls have worked effectively to protect against stormwater run-off or run-on. To address the comments and corrective action noted in the inspection report, Denova engaged a consultant to review its stormwater BMPs to identify further protective measures to include at the location. In accordance with the consultant's recommendation, Denova installed wattles on May 10, 2023 around the stockpiled topsoil and silt fence around the disturbed area perimeter, which will be removed following site stabilization.
