COGCC performed inspections on May 5th and May 8th, 2023.

On May 5th, 2023, Crews were onsite, working on the excavation from the spill and hauling contaminated soil away from the site.

Comment: Excavation is open and impacts remain in-situ both on sidewall and floors requiring additional remediation. Per COA on Doc #403127242: "Within 90 days of spill discovery, submit a Form 27 Site Investigation and Remediation Workplan with a proposed workplan and timeline for remediation of this Release." The Form 27 Initial Report was due by Oct 23, 2022.

Spill has been open greater than 90 days without an approved Form 27 Initial for ongoing remediation. Operator is out of compliance with Rule 912.b. (6)B.ii.

Corrective Action: Pursuant to Rule 912.b.(6)B.ii. A Form 27 if any of the criteria listed in Rules 912.b.(6).B.i-iii apply. If Remediation will continue under an approved Form 27, the Operator will also submit a Form 19 – Supplemental which requests closure of the Spill or Release and includes the Remediation project number assigned by the Director. The Form 27 Initial Report and Form 19 Supplemental requesting closure of the spill was due by Oct 23, 2022.
