Comment: **The former access road has no crop establishment. There is an abandoned shed, pipe risers, and a cement pad at the location that must be removed. The location has not established a uniform crop cover and there are undesirable weeds. There is also an area approximately 75'x75' with no vegetation. It appears there could be a historic impact to soils from the abandoned wellsite. Operator will need to submit a form 27 to investigate and sample soils per Rule 913. Corrective action must be performed immediately.**
