On 5/15/23 at approximately 13:00 hours, I, Inspector Corey De Paolo, Conducted an on-site inspection at CAERUS PICEANCE LLC N PARACHUTE /WF08D-26H26A596. Location #335642 Garfield County Colorado

-While there, I spoke to Kris Gibson of Caerus Oil and Gas. Kris stated that Caerus blew down the flowlines before the bulk of sediment overran the location. Additionally Kris said that both 300 bbl. tanks did have some fluids in them and that they are strapping the tanks daily to insure the structural integrity of the tanks after the landslide.
