Comment:

It was observed in this inspection that the "overall status" is considered to be "in process"; reclamation over the majority of the Location appears to be progressing towards an 80% desirable perennial vegetative cover to that of the adjacent reference. However, there are areas on the east end of the Location that remain bare and unvegetated. Additional revegetation efforts required within these areas.

Cable debris and a utility pole associated with the Location also observed remaining; remaining debris and equipment requires removal.

Small populations of Undesirable Plant Species (Halogeton) observed are established in areas of the Location.

Corrective Action:

Comply with Rule 1004.a and conduct additional reclamation on areas of the Location not progressing towards a uniform vegetative standard.

Comply with Rule 1004.e and Rule 606.c and conduct ongoing weed management to ensure the site remains free of Undesirable Plant Species. Comply with Rule 1002.f and conduct ongoing stormwater management to ensure runoff is managed in a manner that minimizes erosion, degradation and sediment transport; ensure BMPs are implemented to stabilize the seeded soils. Stormwater and weed management required until site receives a passing Final Reclamation inspection.
