<p><b>RECLAMATION COMMENT</b></p> <p>Inspection #696203922 observed that final reclamation has not been performed on this Location. Inspection required Operator to comply with 1004 Rules by 10/1/2022.</p> <p>It was observed in this inspection that corrective actions to comply with 1004 rules have not been taken by the Operator: Gravel has not been removed from Location and access road; Location and access road have not been decompacted, recontoured/regraded and revegetated.</p> <p>It was also observed that weed management activities to keep the Location free of all Undesirable Plant Species has not been performed, or is inadequate: Undesirable Plant Species (Russian thistle, Kochia, Purple mustard, Cheatgrass, Redstem Filaree, Field penny-cress, Bulbous Bluegrass) continues to establish/spread throughout the Location. Ongoing weed management required until Location receives a passing Final Reclamation inspection.</p> <p>Surface Owner appears to be utilizing Location for storage; No Surface Owner Variance Request pursuant to Rule 1001.c has been submitted/approved. Location will remain out of compliance until reclamation has been performed in accordance with 1004 Rules, or a variance to waive reclamation requirements has been approved.</p>	trujilloam	05/24/2023
