	<p>Location does not meet reclamation requirements; vegetation has not achieved uniform distribution. Transects were conducted indicating vegetation is not 80% of the surrounding reference area. Transect #2 assessed the southern portion of the location which meets vegetation standards at this time. Transect #1 assessed the northern portion of the location which does not meet vegetation standards. See attached data results and photos.</p> <p>It appears that additional reclamation work is required to address areas at the northeast of the location where perennial establishment is very poor and annual species dominate. A corrective action date of 11/15/23 is given to allow for a fall seeding however, earlier seeding may be possible/appropriate.</p>	
Corrective Action:	<p>Conduct additional reclamation in accordance with COGCC 1000 series rules. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels.
