Comment: It appears there was noxious weed control performed last fall. The entire length of the access road was not inspected and should be followed up for weed control. There are still some bare areas near and at the location that have not established sufficient vegetation cover. It is unknown if these areas were reseeded last fall but should be monitored and reseeded to facilitate vegetation establishment. Continue to monitor and maintain the reclaimed access road and location until final reclamation is achieved.
