The surface owner's final reclamation variance request to retain a portion of the location for use as a parking and vehicle chain-up area was initially submitted in 2021 and denied due to 500-Series Rule changes and SB181 timing requirements (Form 4 #402722741). The application was refiled through a COGCC Hearing Application on January 26, 2023 (Docket #230100028). The application has been approved and a hearing date was scheduled in April. The docket was removed from the agenda prior to the hearing date and Caerus was informed that the application was not ready for Commission consideration, the docket was awaiting Director recommendations, and

COGCC technical staff would be informed that Caerus inquired about the status of the application. Though the variance request has not yet been approved, Caerus believes we have made a good faith effort to comply with 500 and 1000-Series Rules and requests the corrective action and any associated enforcement be delayed until the Director makes a recommendation on the matter, the application is heard by the Commission, and a final determination is made.

COGCC Decision: Approved pending re-inspection
