Comment:

A variety of debris remains on site. Refer to the "Location" section for corrective action.

Location does not meet reclamation requirements; insufficient vegetative cover/ vegetation has not achieved uniform distribution. The slope to the west and a portion of the location to the east (see attached Photos 1-3) are poorly/sparsely vegetated. Vegetation in these areas is not 80% of the surrounding reference area.

No noxious weed concerns observed at the time of this inspection. This is a drive-through location. Therefore, the access road has not been reclaimed.

Corrective Action:

**Comply with 1004 Rules.**

Date **11/15/2023**

Conduct additional reclamation in accordance with COGCC 1000 series rules. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local soil conservation district. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until final reclamation has passed. Revegetation activities shall be completed no later than 11/15/2023.
