Form 19 #402072127 (6/9/2019): Approximately 4.085 bbls of produced water and approximately 0.015 bbls of oil were released from a flowline riser just off the wellhead on location. The release was contained on working surface within the pad berm and vac truck was used to recover all free fluids. Impacted soil was removed and taken to the Chevron Rangely Landfarm.

Preliminary soil samples were collected on June 14, 2019 from the suspected impact area.
