Interim areas are vegetated with native grasses, forbs and occasional shrubs. Overall, site appears to be progressing towards 1003 standards. However, List B Noxious weeds are common. Whitetop/hairy cress is very common throughout interim areas. A few spotted knapweed and musk thistle individuals were also observed

Therefore, the date the location was observed out of compliance is given as the corrective action date. Operator is encouraged to determine the appropriate measures (type and timing) to treat the particular species.
