This location has one lined blowdown pit which was utilized to contain fluids when the well was in production. Prior to being lined it was also utilized to contain production fluids, and due to the lack of lining, those fluids infiltrated into the underlying soil in unknown volumes. Remediation of the pit is underway, please refer to approved Form 27 Remediation Workplan # 8943.
