Comment: It appears the well was plugged and abandoned on 8/9/2022. There is an open excavation at the wellhead from an active remediation that is still ongoing. The wellhead will need to be cut and capped deep enough to allow recontouring back to the original grade.

There is a lined pit at the wellsite that should have been closed within 3 months of abandonment (11/9/2022).
