The form serves as the initial notification to abandon the FEDERAL 1S-95-20-23 CP (API# 103-10955) well's wellhead, the wellhead line associated with the well, four above ground storage tanks and associated dumphines, two meter houses and associated risers, one line heater and associated lines, one production separator and associated lines, one pumphouse and associated lines, one buried tank, risers associated with the pipeline riser at the pad entrance, and miscellaneous unused risers south of the production separator.
