**INITIAL ACTION SUMMARY**

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Tank battery decommissioning activities were completed at the Cizek USX T 1-8 O SA production facility location on February 6 and 13, 2023. Visual inspection and field screening of soils at the former production facility infrastructure locations was conducted following tank battery decommissioning activities, and five (5) soil samples were submitted for laboratory analysis to determine if a release occurred. Groundwater was encountered in the produced water vessel (PWV) removal excavation area at approximately 6 feet below ground surface (bgs), and groundwater sample (PW-GW01) was collected from the excavation area to determine if groundwater impacts were present. A topographic Site Location Map showing the geographic setting of the site location is provided as Figure 1. Soil and groundwater sample location and field screening data are presented in Table 1. Soil analytical results are summarized in Tables 2 and 3. Groundwater analytical results are summarized in Table 4. The soil and groundwater sample and field screening locations are illustrated on Figure 2.

**PROPOSED SAMPLING PLAN**

**Proposed Soil Sampling**

Will soil samples be collected as part of this investigation? ( Number, type (grab/composite), analyses, and locations of samples ):

On February 6 and 13, 2023, 5 confirmation soil samples were collected from the former separator, PWV, and above-ground storage tank (AST) locations, at depths ranging from approximately 3 inches to 6 feet bgs. The soil samples were submitted for laboratory analysis of BTEX, naphthalene, 1,2,4- and 1,3,5-TMB, TPH-GRO (C6-C10), DRO (C10-C28), and ORO (C28-C40), pH, EC, SAR, and boron using standard COGCC-approved methods appropriate for detecting the target analytes in Table 915-1. Analytical results indicated that constituent concentrations in the 5 confirmation soil samples were in compliance with COGCC Table 915 standards and/or within the range of site-specific background levels. Soil analytical results are presented in Tables 2 and 3.

**Proposed Groundwater Sampling**

Will groundwater samples be collected as part of this investigation? ( Number, analyses, and locations of samples ):

Groundwater was encountered in the PWV removal excavation at approximately 6 feet bgs. On February 13, 2023, a groundwater sample (PW-GW01) was collected from the PWV excavation area and submitted for laboratory analysis of benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, 1,2,4- and 1,3,5-trimethylbenzene (TMB), by USEPA Method 8260D. Analytical results indicated that constituent concentrations in groundwater sample PW-GW01 were in compliance with COGCC Table 915-1 standards. The groundwater sample location is illustrated on Figure 2, and groundwater analytical results are presented in Table 4.

Additional alternative investigative actions described in attached Site Investigation Plan ( summary ):

On February 6 and 13, 2023, visual inspection and field screening of soils were conducted at one location below the former AST, three locations within the PWV removal excavation area, one location at the meter house (MH), and one location at the former enclosed combustion device (ECD). Based on the inspection and screening results, hydrocarbon-impacted soil was not observed at the soil screening locations, and no soil samples were submitted for laboratory analysis from these areas in accordance with the COGCC Operator Guidance for Oil & Gas Facility Closure document. Soil and groundwater sample location and field screening data are presented in Table 1. Soil analytical results are summarized in Tables 2 and 3. Groundwater analytical results are summarized in Table 4. Soil and groundwater sample and field screening locations are illustrated on Figure 2. The laboratory analytical reports are provided as Attachment A. The field notes and a photographic log are provided as Attachment B.

Background soil samples BG-01@3', BG-02@3', BG-01@6', and BG-02@6' were collected from native material adjacent to the former production facility. The background soil samples were submitted for laboratory analysis of total metals and the Soil Suitability for Reclamation Parameters using standard COGCC-approved methods appropriate for detecting the target analytes in Table 915-1. Analytical results for the background soil samples are presented in Table 3.

### SOURCE REMOVAL SUMMARY

Laboratory results indicate that constituent concentrations in the 5 confirmation soil samples collected from the former AST, PWV, and separator locations were in compliance with COGCC Table 915-1 standards and/or within the range of site-specific background levels. As a result, no soils were removed during facility decommissioning operations. The excavation areas were backfilled and contoured to match pre-existing site conditions.

### REMEDICATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Laboratory results indicate that constituent concentrations in the 5 confirmation soil samples collected from the former AST, PWV, and separator locations were in compliance with COGCC Table 915-1 standards and/or within the range of site-specific background levels. Hydrocarbon-impacted soil was not observed during field inspection and soil screening activities at the former production facility infrastructure locations. Laboratory analytical results indicate that constituent concentrations in the groundwater sample collected from the PWV removal excavation area (PW-GW01) were in compliance with the COGCC Table 915-1 standards. Based on the analytical and soil screening data presented herein, assessment is complete at this site and no further activities are required. As such, Kerr-McGee is requesting a No Further Action (NFA) determination for this location.
