Comment:

COGCC Staff, Chris Binschus, met with an Operator representative to conduct a site investigation. Operator has performed a preliminary soil analysis at the location, is in the process of developing a Reclamation Plan and will conduct further reclamation when environmental conditions allow so.

At the time of this inspection, the location consists mostly of annual weeds with little to no perennial vegetation that is not reflective of reference areas; perimeter fencing is present and will likely remain in place during final reclamation; access road remains in place. Weedy annual vegetation has spread off location along portions of the perimeter location. Refer to the attached inspection photos.
