On Monday, 06/12/2023, Inspector Kirby Burchett, conducted a follow up field inspection at Caerus Piceance LLC on the Love Ranch Fee 1 well, Location #316151, in Rio Blanco County, Colorado.
This location is within or in close proximity to a CPW District Wildlife Management Plan with Black Bear, High Priority, NSO, and Density Habitat Regulations.

Any Corrective Actions from previous Inspections are still applicable.

Follow up is from Corrective Actions observed during Inspection #702500997 on 3/13/23 and Operator submitted FIRR #403362182.

While there during normal operations the following compliance issues were observed:

1. Random debris.
2. Unused equipment.
3. Valve can open to wildlife.
4. Insufficient Stormwater BMPs.
5. Wellhead sign missing required information.
