How was extent determined?			
Following cut and cap operations at the Four Raith Unit 1 wellhead location on June 20, 2023, confirmation soil samples were collected from the former wellhead and submitted for laboratory analysis of the full COGCC Table 915-1 suite using COGCC-approved methods appropriate for detecting the target analytes. Preliminary analytical results received on June 21, 2023, indicate that the benzene, xylenes, 1,2,4-trimethylbenze (TMB), 1,3,5-TMB, and TPH concentrations in wellhead soil samples WH-B01@8', WH-S01@7', WH-W01@7', and FL-B01@4' exceeded the COGCC Table 915-1 Cleanup Concentration. Assessment activities are ongoing and will be summarized in a forthcoming quarterly Form 27-Supplemental Site Investigation and Remediation Workplan under Remediation Project No. 29090 (approved Form 27 Document No. 403378231). A topographic Site Location Map showing the geographic setting of the release is provided as Figure 1. The soil sample locations are illustrated on Figures 2 and 3. Soil sample location and field screening data are provided in Table 1. Soil analytical results are summarized in Table 2. The preliminary laboratory analytical report is provided as Attachment A. Field notes and a photographic log are provided as Attachment B. The State Notification email is provided as Attachment C.
