Reclamation rules require reclamation activities to be conducted within three months of plugging on cropland. Well was plugged 4/18/2018. The access road has bare ground throughout the disturbance and does not appear reflective of adjacent crop reference area.</p> <p>The tank battery is associated with the Edwards 43-9 well API #123-20867 and is not associated with this inspection report.</p> <p>Comply with Rule 1004.
