Comment:

This location does not comply with Rule 1004. During this inspection, Staff observed that an apparent historic salt kill area is not progressing towards Rule 1004 standards. The impacted area has evidence of non-uniform vegetation cover resulting in areas of exposed soil and undesirable vegetation (Colorado List B & List C Noxious Weeds-musk thistle and cheatgrass; and kochia) were observed growing throughout. The former well location appears to be progressing towards Rule 1004 vegetation standards with evidence of desirable species observed. Further site investigation and reclamation activities are required by the Operator in order for the location to pass final reclamation standards. Refer to attached inspection photos for documentation.

Corrective Action:

Comply with Rule 1004. Investigate impacts from apparent salt kill areas and reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management. Corrective action date is the date the location was observed out of compliance.
