One of the two unmarked deadman from the previous inspection has been marked however the other remains unmarked. During this follow up inspection another unmarked deadman was also found.

While there, I observed normal production operations.

During this inspection the following compliance issue was observed:

1. Equipment - 2 unmarked deadman with a CA date of 07/07/2023

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
