Comment: The well location, access road and tank battery appear to meet final reclamation regulations and standards. Due to the autotoxicity behavior of alfalfa, new alfalfa may not establish into an existing mature stand of alfalfa. Operator has instead planted an approved surface owner perennial grass seed mix to supplement alfalfa. Sufficient perennial grass cover has established and meets Rule 1004 vegetative standards.
