A site investigation was conducted pursuant to COGCC Rule 911 at the UPRC T4N-R67W-S23 L01 Tank Battery location.

Four (4) grab confirmation soil samples were collected from the produced water vessel excavation (2), beneath the ground oil tank (1), and at the separator (1). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, EC, SAR, pH, and boron. One (1) waste characterization sample for COGCC Table 915-1 metals was collected.

All samples collected were analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

A background sample for pH and COGCC Table 915-1 metals was collected. Residual arsenic, and barium at the produced water vault excavation are consistent with background comparison.

The source was delineated through an environmental site assessment. Groundwater was not encountered during the assessment. Noble will complete source removal activities at the site to address residual TPH at the site. Noble proposes an amended Table 915-1 analytical plan to include TPH C6-36, Table 915-1 organics in soil, and pH. Noble proposes the use of residential soil screening levels as groundwater was not encountered and does not appear threatened by the historical release.

REMEDIAL SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Provide a brief narrative description including: technical justification, schedule for implementation, estimated time to attain NFA status, plus plans and specifications for the selected remedial action technology.

Source excavation activities will be completed to remove the residual source material at the site. Excavation activities will be scheduled pending landowner/access approval - excavation activities are tentatively scheduled to begin August 1, 2023. An estimated no further action request may be submitted in September 2023, pending completion of source removal and soil compliance with COGCC Table 915-1. Noble proposes the use of residential soil screening levels as groundwater was not encountered and does not appear threatened by the historical release.
