Operator Comment: KPK is aware of the high rainwater at this open excavation site. The site is located in close proximity to Eagle's nest so all site activity has been suspended to comply with the COGCC CPW requirements. On 6/1/2023, KPK was granted short term variance to use a vacuum truck to lower the elevation of the water in the excavation. The water removal occurred that same day and removed 3 truckloads of water from the excavation. Water with a

sheen was removed at that time. KPK is willing to revisit the site if the COGCC and CPW will remove the access restrictions that protect the Eaglets

COGCC Decision: **Not Approved**

COGCC Representative: Operator has not proposed any fledgling monitoring or remedial action plan once eagles fledge, therefore this corrective action cannot be approved.
