Comment: This location does not comply with Rule 1004. During this inspection, Staff observed that the location does not appear to be progressing towards Rule 1004 standards. The access road does not appear to be connected to any other oil and gas locations and has not been reclaimed. The well location does not appear to be reflective of adjacent reference areas with evidence of undesirable vegetation (e.g. kochia and Colorado List C Noxious Weed cheatgrass) and exposed soils. Refer to attached inspection photos.

Corrective Action:	Comply with Rule 1004. Reclaim entire access road and reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.
