## Other Potential Receptors within 1/4 mile

The Talpers 2 former location is surrounded by cultivated fields in all directions. There is 1 ephemeral stream mapped approximately 1,400' west. Depth to ground water is unknown, however, one boring advanced in November 2016 to 40 feet below ground surface did not encounter ground water. Based on the Division of Water Resources, Groundwater Levels in the Lost Creek Designated Groundwater Basin paper published in 2020, it is anticipated that the depth to water will be approximately 80 feet. There are no sensitive areas or wildlife habitats identified within a quarter mile of the former location.

### INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

The equipment has been removed from the Talpers 2 site. A site investigation conducted in June, September and November 2016 indicated the presence of soil impacts greater than the COGCC Table 910-1 benzene and TPH standards beneath the former produced water vault to a maximum depth of approximately 40 feet. In January 2016, approximately 200 cubic yards of impacted soil were removed from beneath the former produced water vault to a depth of approximately 15 feet.

When it appears that the SVE system has reached the limits of its operational effectiveness, confirmation soil borings will be advanced to determine whether the subsurface soil impacts have been adequately remediated. The Residential Soil Screening Levels (RSSLs) will be applied to this site since the depth to groundwater is approximately 83 feet.

Sodium absorption ratio (SAR) levels were elevated in shallow soil samples during the site investigation. These soil impacts will be addressed after remediation of the petroleum constituents has been completed. The SVE system (remediation building, generator and propane tank) are located in the area of high SAR concentrations which precludes soil removal at this time.

To remediate the soil impacts in the vadose zone, a propane-powered soil vapor extraction (SVE) system was installed at the site on 12/16/2021.

## REMEDICATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Provide a brief narrative description including: technical justification, schedule for implementation, estimated time to attain NFA status, plus plans and specifications for the selected remedial action technology.

As a result of the residual subsurface impacts at the Talpers 2 location, PDC installed an SVE system to remediate soil impacts. The system consists of three SVE wells that are individually piped to a remediation building; these SVE wells are screened from 25 to 35 feet, which is approximately the depth of the residual petroleum hydrocarbon impacts. The 6.5 HP Reitschle SAP-380 SVE vacuum blower operates at approximately 50 cfm and 50" H2O. The remediation system is powered by a propane-fueled generator. The remediation system has operated on a 24/7 basis since installation.

SAR levels were elevated in shallow soil samples during the site investigation. These soil impacts will be addressed after remediation of the petroleum constituents has been completed. The SVE system (remediation building, generator and propane tank) are located in the area of high SAR concentrations which precludes soil removal at this time.

## OPERATOR COMMENT

The SVE system appears to be approaching the limits of its operational effectiveness. PDC will evaluate the current emissions rate and consider deactivating the system. Two soil borings will be advanced in the impacted area to a depth of 35 feet bgs to determine if residual petroleum hydrocarbons remain in place. Soil samples will be collected at the same depths and locations as previous borings where impacted soil was encountered. These samples will be analyzed for Table 915-1 organic constituents. If those soil samples achieve the COGCC Table 915-1 Residential SSLs, the SVE system will be deactivated. If elevated concentrations remain, the SVE system will be reactivated. A supplemental Form 27 will be submitted to document the analytical results of soil samples from the proposed borings.
