This location does not comply with Rule 1003.b. It appears the Operator has performed interim reclamation activities with evidence that topsoil has been moved back to its relative position and contoured/graded to reflect reference areas. However, the interim areas largely consist of undesirable vegetation (e.g. kochia and russian thistle debris) and areas of non

Corrective Action

Perform reclamation in accordance to Rule 1003. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until the location meets Rule 1003 standards. Corrective action date is the date the location was observed out of compliance.
