A site investigation was conducted pursuant to COGCC Rule 911 at the JOHNSON T4N-R64W-S29 L02 Tank Battery location.

Grab confirmation soil samples were collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), and at the separator(s). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

A Site Assessment was conducted on 4/19/2023 to delineate impacted media. Six soil borings were advanced in the area of impacts. BH01 was advanced at the same location as the waste characterization sample FS01 @4' to vertically delineate impacts at that location. BH02-BH06 were advanced surrounding BH01 to vertically and laterally delineate impacts identified at FS01 @4'. Soil samples were collected and analyzed for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil, metals in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. Each of the five soil borings were converted to temporary groundwater monitoring wells. Five groundwater samples were collected and analyzed for BTEX, naphthalene, 1,2,4-trimethylbenzene, 1,3,5-trimethylbenzene, and inorganic parameters. Upon review of the site assessment lab data, a subsequent Form 27 will be submitted.
