COGCC Inspection Report Summary  
 On Thursday 6/29/2023, I, Inspector Scott Ramsey, conducted a follow up inspection at TEP Louthan, at Location # 335439 in Garfield county Colorado.  
 Any Corrective Actions from previous Inspections that have not been addressed are still applicable.  
 While there, I observed normal production operations. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management. Operator (TERRA) has provided there Piceance Basin Storm water Manual of BMP's (SC-4) for a tracking pad.

C/A (Stored equipment (ECD disconnected) from previous inspections is still present form DOCUMENT # 700703382, # 700704215 and # 707800169. Therefore C/A date remains the same 3/10/23.

Location is within or close proximity to CDPHE air pollutant emissions inventory.  
 During this inspection the following compliance issues were observed:  
 1. Meter calibration card not conspicuously posted.  
 2. Random debris  
 3. Stored equipment (ECD is disconnected)  
 4. Venting tank. Video taken with FLIR camera.
