INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

In accordance with COGCC Rule 911, this form serves as notification for the decommissioning and abandonment of the Ikenouye F 28-65HN production facility. The ground and sub-surfaces will be visually inspected for hydrocarbon impacts during equipment decommissioning. In addition, on-site dump lines located between the separator and tank battery will be removed by pulling from either end during decommissioning activities. Field observations and photo documentation will be recorded in a field inspection form for submittal to the COGCC.

Grab soil samples will be collected below and/or adjacent to applicable facility equipment, as defined in the Rule 911.a.(4) guidance document (9/20/21), for field screening purposes. Soil samples will be submitted for laboratory analysis of BTEXN, TMB's, PAH's, TPH (C6-C36), pH, EC, SAR, and boron by COGCC approved methods, with the exception of the sample(s) collected below the AST(s) which will be analyzed for BTEXN, TMB's, PAH's, and TPH (C6-C36).
