Following removal of the tank, four sidewall soil samples and one base sample will be collected from the open excavation and submitted for laboratory analysis of all Table 915-1 constituents. For comparison to background soil conditions, up to four soil samples will be collected from nearby, undisturbed native areas and submitted for analysis of Electrical Conductivity (EC), Sodium Adsorption Ratio (SAR), pH, Boron, and Arsenic.
