**Photo 8.** Taken near the southeast corner of the location. The berm material does not appear to be properly stabilized with evidence of unconsolidated material. It appears stormwater run-on has eroded a portion of the berm; additional maintenance or implementation of more robust BMPs is required.

**Photo 10.** Taken from the northern, central, portion of the stormwater ditch and berm. The berm material does not appear to be properly stabilized with evidence of unconsolidated material. It appears stormwater runoff has eroded a portion of the berm; additional maintenance or implementation of more robust BMPs is required.





**Photo 11.** Taken from the northern, central portion of the location. It appears that grubbing activities have recently occurred. The Operator shall ensure that all topsoil has been separated and stored in accordance with Rule 1002.b. A follow-up inspection will be performed at a later date to verify compliance with topsoil salvage operations.
