PLUGGING RECORD

INSTRUCTIONS

Within thirty (30) days after the plugging of any well, the owner or operator thereof shall file this form in duplicate for wells on Patented or Federal lands, and in triplicate for wells on State lands, give a detailed account of the manner in which the abandonment or plugging work was carried out, including the nature and quantities of materials used in plugging and the location and extent (by depths) of the plugs of different materials; records of the amount, size and location (by depths) of casings and junk left in the well; and a detailed statement of the volume and weight of mud fluid used.

DETAILS OF WORK

Set DC bridge plug on tubing at 3925' KB. Loaded tubing and annulus with water and cement squeezed perforated interval 4385-4396' with 100 sacks 50-50 Pozmix cement and displaced with water. Staged cement for 10 minutes, pressured to 1500 psig and staged an additional 10 minutes. Left 50 sacks cement in the formation and 50 sack plug in the casing. Pressure tested squeeze job to 2100 psig with no apparent leakage. Spotted 25 sacks of cement on top of bridge plug and pulled tubing. Shot loose 5-1/2" production casing at 3110' KB and pulled pipe. Hole filled with 10 lb/gal mud to base of 8-5/8" surface casing at 160' KB. Spotted 30 sack cement plug from 160' KB to 65' KB, and 10 lb/gal mud from 65' KB to 18' KB. Placed 5 sack cement plug on top. Cut off surface casing 3' below ground level and welded steel cap on top of surface casing. Work completed October 6, 1965.
