On Wednesday, July 12, 2023 at approximately 13:00, I, Inspector Brittani Santistevan, conducted an on-site inspection at COLFER 13N-34HZ (Kerr McGee Oil & Gas Onshore), at API #: 05-123-34194 in WELD COUNTY Colorado.

While there, I observed a producing pumpjack.

During this inspection the following possible compliance issues were observed:

1. It appears to be stained soil at pumpjack. Conduct maintenance on equipment, cleanup stained material and review self inspection processes per Rule 1002.(2).d. (Corrective Action Date: August 12, 2023) See attached photos #3.

2. Unused equipment at pumpjack. Reconnect or remove from location per Rule 606 (Corrective Action Date: August 12, 2023) See attached photo #4.

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
